## RESISTANCE TN GREECE -NOW TO FIGHT AUSTERITY!

The depth of the resistance to austerity felt by the Greek In analysing this, we have to make a couple of very simple people was admirably demonstrated at the re-run of the elections, which saw the SYRIZA coalition of the radical left gain a third of the votes.

In fact, the majority of the Greek people voted for parties opposed to the 'memorandum', i.e the EU/ECB/IMF or 'troika' imposed deal which saw the bankers bailed out at the expense of the soverignty of the Greek nation.

It was only the scandalous toadying of the advocates of austerity, PASOK and New Democracy, who ensured the survival of the memorandum and the ongoing suffering of the Greek people.

But although the opportunity for political power for the Left has abated for now, the result still shows an unprecedented turn away from the stability of a discredited old party system towards a radical challenge to austerity.

It has been noted that much of the growth of support for SYRIZA has come from now demoralised parties of the soft left and the centre, as if such an influx of support renders the success of SYRIZA as tainted or even counterproductive for the battle against austerity. Furthermore, the fact their immediate opposition to the terms of the memorandum does not yet go so far as to meet outright opposition to the Euro or the EU has also been a subject of much debate amongst the left outside Greece.

One, that the influx of support for SYRIZA is what can be expected to happen when the politcal circumstances change to such a considerable degree as we have seen in Greece over the past two years. If such a movement did not happen, then the political system of any nation would be locked into stagnation. Furthermore, the previous political home of a vote does not taint the current recipient. Otherwise, where would the votes that 'should' have gone to the KKE come from? The fact that support for PASOK collapsed and fled to the radical left does not make the subsequent increase in support for SYRIZA meaningless.

Two, that just because the dynamic of resistance has yet to reach its full political conclusion does not mean that the process is without meaning. There is a key role for intermediate demands. Once the impossibilities of reclaiming sovereignity and fighting austerity within the Euro becomes apparent, and the wider reactionary role of the European Union has been exposed, then the people will start to ask harder questions and seek revolutionary answers. To argue that until the point is reached that all struggle is pointless is lead the people into the dead end of the 'lesser evil' and eventual demoralisation and surrender.

The next step remains the creation of a fierce anti-austerity opposition, both within Greece and across Europe, and for the fight to move from the ballot box and onto the streets.

## ☆ BREAK THE MOULD -BUILD ANEW!



Following on from the May 10th strike over pensions taken by PCS, UCU, RMT and others, it is now apparent that nothing further will happen to advance this dispute until the autumn. Although the stoicism of PCS and the other unions can only be applauded, it is now painfully apparent that the task of uniting and fighting these imposed changes has proven to be beyond the trade union movement in Britain.

It is always important after such developments not to sink into abject defeatism, but any sober analysis of the situation would conclude that with the imposed changes having had months to bed in that the campaign is further away from being won, and that although the campaign has not been conceded that any united action in the autumn will be on a multiplicity of issues, of which pensions will be only one.

All this means that all the key events of 2011 - the 26th March rally in London, the 30th June & 30th November strikes - which represented such a massive step forward for the movement, have taken us no further forward. It is only fair then that we ask how will the movement rise to defend jobs, fight for fair pay and defend the right to strike over the coming months if unity is so painfully built and so easily squandered.

The League of Communists in Britain is therefore asking the question - what can be done to rebuild and renew the movement? It is clear that the current basis of workers organisation is insufficient. How can the organisational basis of the labour movement be improved?

We need a new basis for workers organisation in Britain, the state, and the interests of capital. Often this is not covering such areas as workers self-organisation, rank & done openly or even self-consciously but through and file left opposition in trade unions, better and different unofficial and covert means which work against the federation for trade unions activity, greater political official modus operandi of the state apparatus. The education, organising migrant workers and the interlocking of parts of the state and the needs of political unemployed, and demanding a qualitatively different and financial elites needs reviewing in the light of such model for how we organise.

It aptly demonstrates the chaos of government. Any conception of a monolithic and methodical state apparatus cannot be squared with the reality of government by officials who are often arbitrary in their governance, if not totally random. Furthermore, the administration of power is almost casual in it's disorderly, lackadaisical nature. Accountability is hard to wield against a state machine which seems ad-hoc and semi-improvised. We would be doing ourselves a disservice by imaging the state as a welloiled machine, but it is instead a complex and dysfunctional and chaotic system which often works against itself.

The level of corruption as manifested by the shared

interests between political, media and oppressive arms of widespread illegality in the workings of government.

## THE END OF HUMANITARIAN INTERVENTION




The ongoing massacre in Syria is ample proof that the neoliberal project of 'humanitarian intervention' is dead and buried.

In particular, without Russian suport all attempts at military leverage have failed, and all the while the world awakes to massacres the like of which have not been seen for decades.

It is vital that imperialist intervention in Syria is opposed; however, we must also send our solidarity and support to the Syrian people in their battle against oblivion. The League of Communists stand shoulder to shoulder with the Syrian people against both the Assad regime and the failed beasts of Western neoliberalism. The world must fight for justice for the Syrian people and for an end to the war that is being waged against them – and urgent humanitarian and political support is required.



The League of Communists in Britain was formed on 30th November 2011, and is a non-party, political organisation dedicated to grassroots political activity and practical solidarity. Communism in the 21st century is not a struggle for state power, but the struggle against it; it is the engagement in a radical, decentralised politics, which manifests itself as a challenge and resistance to exploitation and oppression on the basis of class, gender, sexuality, disability, nationality, immigration status, species and religion. Resistance and practical solidarity is the basis for all of the Leagues political work. We work to defend human rights and political autonomy, provide humanitarian assistance and support those in struggle. We publish a regular newspaper, 'Subversion', which acts as a focus for politics and organising. Our members are active in trade unions such as PCS, Unite and the NUT, and campaigning groups such as UK Uncapped, refugee support organisations and the anti-cuts movement.

We believe in a radical politics which is decentralised and broad; we do not have a structure of committees or branches, we have no conditions of affiliation or payment of dues, and we do not work on the basis of an agreed political 'line'. Instead our emphasis is on practical political work, and not on party building. Affiliation is open to anyone, regardless of membership of other organisations, who agrees with our core mission. statement and signs our equalities disclaimer. Affiliation costs £1 per month.
