ACCIDENTAL BOYCOTT

The League stands by the legitimacy of Resistance by On Thursday 15 November 2012, the elections for police £100,000.

> Little excitement were generated by the elections, which took place in 41 Police authority areas (London not included).

> The coalition government had stated that they are calling these elections in order to make police more accountable and free up more officers for 'frontline' duties.

> This reasoning is nothing but a smokescreen for the real reason the coalition has called for the creation of such expensive posts.

> Currently the local police authority is composed of local councillors elected in local elections. This is a perfectly democratic and transparent way for local people to elect a committee that holds a local police force to account.

> The new Police Commissioner elections will give the powers of local police authorities to one elected person who will stay in power for four years.

> This is significantly less democratic and more expensive than a committee composed of local councillors from the police force area. It also further removes the control of the police away from citizens and into the hands of one person.

> When the coalition government has sought to devolve power it always wishes to devolve power to a single figurehead such as a local mayor or police commissioner who does not have the power to carry out their duties and change peoples lives in the way in which the public may expect them to.

> The coalition government does this is for the partly the same reasons they like to privatise functions which should be owned and operated in the interests of all citizens.

If you privatise or devolve a public function to a company or straw representative, it means you no longer have to take responsibility for it as a national government and can simply point and express disapproval at the poor sap who has failed in the eyes of the public.

The local mayors and Police Commissioners are nothing but ready-made scapegoats for a government who cannot yet get away with privatising the police but nevertheless wish to give up any responsibility for the carrying out of decent public functions.

Police Commissioners cannot influence people's living standards, unemployment or the rate of drug addiction in their local areas any more than local mayors can.

The government is intent on creating more scapegoats even though the majority of cities voted against having local mayors in the last referenda on the issue.

The police should be held to account better than they are currently. There should be reform of local police authorities so people are more aware of the function the local police authority performs and of how they can influence and vote on how they are policed.

There should be more accountability, greater collective control of the police and more legal rights for citizens.

The way proposed by the government however does not represent the correct way forward and is merely a way of central government devolving responsibility but without the power to do anything about the crime which effects local people.

A large number of people therefore openly advocating not voting or spoiling the ballot paper for these elections.

This was because every vote in this election will inevitably be construed as a giving the new system further legitimacy and acceptance.

The biggest talk about the elections in the media was about how low turnout will be. In the event, the turnout was a miserable 10-15% - an indictment of this counterproductive and unjustified meddling in local democracy.

Hopefully, the new 'Sheriffs' will now be left high and dry and on the road to obsolescence.

Instead our emphasis is on practical political work, and not on party building. Affiliation is open to anyone, regardless of membership of other organisations, who agrees with our core mission. statement and signs our equalities disclaimer.
